 - This rebate form with all information completed (failure to supply all information will void your rebate eligibility)
 - A copy of the receipt for the New Eligible Pantone Graphics Product(s) with the Pantone Graphics Product(s) clearly identified, and
 - Your Old Eligible Pantone Graphics Product
